FROM THE HELM

April 2008

Busy month, with hosting the Catalina 22 and Flying Scott regional regattas, both ably chaired by Bill Robertson, with Brainerd Cooper as PRO. Bill also came in third in his C22 behind two national champions, and Rob Fowler came in first in the Scott regatta, with Tom Clark third. PYC was complimented by attendees at both regattas for a job well done. Thanks to all that helped and sailed. Great going!

A word of explanation and apology is needed on delayed dues billing and financial reporting. Our new **Treasurer, Carol Cofield,** has been struggling with a new computer and new financial software. Seems we can't live without technology these days, but living with it isn't easy either. She thinks she finally has things working. You may have received your billing by the time you receive this *Ear*. We should be on schedule from here on.

Some may have heard about **an early swim** I took during a windy Saturday race this spring, which brings sailing **safety** to mind. I keep flotation vests on *Tivoli*, the boat I sail all year if weather permits. Problem was that I forgot to put them on *Li'l Buoy Blew*, my C22 for the Saturday race. I did have legal preservers on board, but not the comfortably wearable kind. My crew, **Sandy**, and I both realized we had left the vests on *Tivoli* but didn't want to take the time to go back and get them.

By the third race, the wind was building to over 20 knots, too much for us. Sandy tried to release the jib and couldn't. I jumped to the lee side to free it when

a gust hit, sending me overboard. I think that's the first time ever for me, but *there's always a first*.



The water was cold, but fortunately not debilitating, and I maintained contact with the boat because I grabbed the mainsheet as I went over. I was able to reboard, primarily because I had installed a permanent boarding ladder on the stern. Under the conditions that day, I would not have been able to reboard without it.



At least I did something right. Since I single hand often, I had installed a similar ladder on *Tivoli*, my Oday 25, some years ago. I also had the regulation attached throwable preserver on board my C22, but we both forgot to toss it out in case I lost contact with the boat. Good to have it, but not good to not use it.

I *highly recommend* to all sailors, racers in particular, to of course first wear a vest in high wind conditions regardless of the time of year, and install a **boarding ladder** you can access alone from the water. I often hear about doing safety drills in the sailing press, and now after the fact, will be doing so. "All's well that ends well," as they say.

Bryson Lesley donned his blue blazer and visited the Baylor, GPS and Bright Schools to solicit attendance for the Opti training program this summer. He was warmly received, and we hope to have some new students. All you members with children or grandchildren in the 8 to 14 year age range need to sign them up. You may have seen work under way in the Opti area for new docks and a new covered training pavilion. Bryson has been busy.

CATALINA 22 CHATTANOOGA CHALLENGE and REGION 3 & TN STATE CHAMPIONSHIP

The 2008 Chattanooga Challenge was held the weekend of April 18, 19, and 20. Fleet 95 was proud to host the Region 3 Championship in conjunction with the Challenge, which has also traditionally been the Tennessee State Championship. The regatta was open to all Catalina 22's, but the Region 3 championship was limited to boats who are members of Region 3 Fleets and the Tennessee Championship was limited to boats who are members of Tennessee Fleets.

We invited **Joe Waters** to come in on Friday to supervise some practice starts and to conduct a seminar that evening. The wind was quite strong and puffy Friday afternoon, so most boats elected to preserve their sails and stay on shore Friday afternoon. The few boats that went out were treated to some one on one coaching from Joe. That evening Joe put on an excellent **seminar** that was enjoyed by everyone, beginning sailors and veterans alike. Fleet 95 sends out a sincere *thanks* to Joe for helping us out with this event.

We arrived Saturday morning to ideal sailing conditions. The winds were steady out of the Southwest at about 15, with some puffs approaching 20. The skies were partly cloudy with abundant sunshine. It was pleasantly cool, with highs in the upper 60's.

After registration, we had a record turnout of 29 boats. Boats came in from **Tennessee**, **Georgia**, **Alabama**, **Indiana**, **and Michigan**. There were 16 boats in Gold Fleet and 13 in Silver. Our **PRO Brainard Cooper** set up a near perfect Windward/ Leeward course.

Dennis Slaton in *Tar Baby* led the 1st race from the start and would have won it, but got confused about the location of the finish line and ended up in 3rd behind **Reid Collins** in *Chicken Ship* and **Bill Robertson** in *Blind Hog*.

Dennis had it together for the second race and won

In the **Silver Fleet**, Saturday's races were dominated by **Matt Perry** and **Tom Prevost**. Matt ended Saturday with a 1st and two 2nds, and Tom finished just behind with a 1st, 2nd and 3rd.

Everyone was worn out and hungry after a hard day of sailing. We enjoyed a wonderful catered dinner by Events with Taste, a few malted beverages, and most people retired early to rest up for Sunday's racing.

Minutes of March meeting approved. George moved, Healy seconded.

OLD BUSINESS:

• Walt stated that there had been an e-mail vote whether all club members should be automatically invited to all club functions or whether it should be left to the discretion of the event chairman. The vote was 5 for and 1 opposed, assigning the decision to the regatta chairperson.

OFFICER REPORTS:

Steve George, Past Commodore: No comments

Brainard Cooper, Vice Commodore — Racing:

- Race Committee for the Chattanooga Challenge needs more volunteers.
- Carl Labbe has resigned from PYC and retired from doing the mailed RC notices. Brainard will do them until he finds someone else. Steve Adams has bought Carl's boat, but Steve needs to apply for membership. Carl's boat has been in slip B-29.

David Bergevin, Rear Commodore — Membership:

• Resignation letter from **Carl Labbe** stated, in part: "I have thoroughly enjoyed my years with the Privateer Yacht Club, and all the members. Although

I didn't race very often, many folks will remember the old man with the grandchildren sailing, towing them behind the boat, fishing, swimming and diving from the boat, etc., and just sailing lazily along by myself on a warm day. WOW!! What a way to grow old!!"

- As of Carl's resignation, we have 124 family members, and the cap is 130.
- **Guy Campbell** has completed his year as an Associate. Snyder moved and George seconded and a vote accepted him as a Family Member. Now we have 125 Family Members.
- Sandy VanDen Branden has completed her year as an Associate. George moved and Rathjen seconded. Vote accepted her as a Family Member. Now we have 126 Family Members.
- Andy Duke has been listed as an Associate for one year, but he has made no entries in the Associate's logbook and has paid no dues. Rathjen made and Healy seconded motion to drop Duke's membership. Passed.
- We currently have 10 Associate Members in the queue, and only four Family Membership slots open.

John Rathjen, Chairman of Land Committee:

- John has been working on a letter to the sons of Marge and Buzz Lamb about cabin ownership. Copies have been circulated to the board via e-mail. Richard MacLean, lawyer and club member, has reviewed it and made a couple of suggestions. John read the latest version to the board.
- **Ken Simons** was recognized on behalf of the Lamb sons. Ken stated that **Stuart Lamb** is working in Iraq for another 2 months. Both sons want to keep ownership of the cabin. They just found out that they can obtain membership forms on the club website. Ken checks the cabin weekly. Kerry Lamb checks it about every 3 weeks. Ken requested, since the "boys" grew up in that cabin, that they be granted family membership, allowing them to skip the one year Associate Membership requirement.
- After a long discussion about the issues involved the general consensus was that the board felt it would

- George moved and Cofield seconded a motion to accept the letter submitted by Rathjen, which passed.
- **Rathjen** moved that Simons' request be put to an up or down vote. Healy seconded. The request was voted down.
- **Rathjen** stated that in 2010 the bulk of the leases will expire, and the club will have to look carefully at the lease language.

Pete Snyder, Secretary — Editor, *Private Ear*:

• *The Private Ear* will be included on the PYC website. Pete needs to get the modified pdf files (without treasury statements) to Bill Robertson by the next board meeting.

Carol Cofield, Treasurer:

• Carol is still having difficulties with the **new soft-ware.** But, she found someone at Rob Fowler's office who has begun to help her.

Dieter Kuberg, Dock Meister & Slip Director:

- Names need to be on trailers, or slots with noname trailers will be vacated. Scott Cline will show anyone how to use the stencils in the club storeroom.
- There are only one or two wet slips available. Dry slips are also about full.
- **Bergevin** commented that the TVRA requires active registration on all boats in the water.
- **Kuberg** added that all boats should have insurance.
- **Kuberg** stated that according to the wet slip policy, just because someone buys a member's boat, he does not automatically get the slip with it.

John Rathjen, Club Boats:

Work completed to date:

- Both pontoon boats have been cleaned up, batteries charged, gas cans filled, engines verified operable, and minor repairs made.
- The **Boston Whaler** has been functionally checked and is OK for use, except the registration has not been located. Registration cards are on the pontoon boats. The **Carolina Skiff** card is in hand.
- Two sets of keys for both pontoon boats and both chase boats have been sorted and identified with ID tags. The primary set is hanging by the stereo player next to the kitchen door. The spare set is located in the medicine cabinet in the kitchen.
- The damaged area on the **aluminum rowboat** has been prepared for welding and the boat has been taken to Steve Morgan's shop for repair.
- A full set of RC signal flags and a set of aluminum course marker signs have been fabricated for the CSC pontoon boat and are available on board.
- A good quality battery charger with engine starting capability has been purchased and located in the storeroom.

Open items:

- Locate registration for Boston Whaler.
- The plywood deck on the CSC pontoon needs to be replaced in the off season. A temporary repair (by scabbing plywood over the rotted areas) needs to be made ASAP.
- The wiring on both pontoon boats needs to be checked for continuity and repaired as required.
- A general checkout of the Carolina Skiff still needs to be done.
- The frame for displaying course markers needs to be replaced on the CSC boat.

Bryson Lesley, Director of Building, Grounds and Docks:

- Water is now available on C, D and E Docks.
- The **Opti dock** base is done, have yet to do the shelter.
- **Bryson** got a quote from a paving contractor for four inches of concrete with wire mesh for \$2.04 per square foot, if we will do the grading and sub-grade preparation. Another quote for asphalt was \$3.60 per square foot. There is approximately 10,000 sf in

Paul Healy, Social Director:


- There is no social event this month.
